- To be valid, a form of proxy together with any power of attorney or other authority, if any, under which it is signed, or notarially certified copy 8. thereof, must be lodged with the Company's branch share registrar in Hong Kong, Tricor Abacus Limited, at Level 22, Hopewell Centre, 183 Queen's Road East, Hong Kong not less than 48 hours before the time for holding the meeting or any adjournment thereof.
- 9 A proxy need not be a member of the Company, but must attend the meeting in person to represent you.
- 10. Pursuant to Rule 13.39(4) of the Listing Rules, any vote of shareholders at the meeting must be taken by poll except where the chairman, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands. The Company must announce the results of the poll in the manner prescribed under Rule 13.39(5) of the Listing Rules.
- 11. Any alterations made in this form should be initialled by the person who signs it.
- Completion and deposit of the form of proxy will not preclude you from attending and voting at the meeting if you so wish., and in such case, the proxy previously submitted shall be deemed to be revoked.
