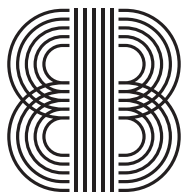

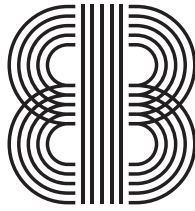

## **INTRODUCTION**

Reference is made to the prospectus of E. Bon Holdings Limited dated 14 December 2022 in relation to the Rights Issue (the “**Prospectus**”). Terms defined in the Prospectus shall have the same meanings when used herein unless the context otherwise requires. In accordance with the terms set out in the Prospectus, the Directors have provisionally allotted to you a number of Rights Shares on the basis of one (1) Rights Share for every four (4) existing Shares held and registered in your name(s) as at the Record Date (i.e. Tuesday, 29 November 2022) at a subscription price of HK\$0.192 per Rights Share. Your holding of Shares as at the Record Date is set out in Box A in Form A and the number of Rights Shares provisionally allotted to you is set out in Box B in Form A.

The Rights Issue is only underwritten on a best effort and non-fully underwritten basis. In the event of under-subscription, the Underwriter has no obligation to and may not subscribe for or procure the subscription of any Rights Share not being taken by the Qualifying Shareholders. Pursuant to the Company’s constitutional documents and the Companies Act, there are no requirements for minimum levels of subscription in respect of the Rights Issue. ## **FRACTIONAL ENTITLEMENTS**

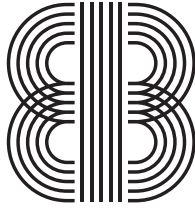
## **GENERAL**

## 緒言
